





Information requested by the Education and Workforce Select Committee during presentation of the Initial Briefing on the Equal Pay Amendment Bill on 13 February 2019

## **Purpose**

- 1. This paper provides the additional information sought by the Committee in relation to the Equal Pay Amendment Bill (the Bill) at its meeting on 13 February 2019.
- 2. The Committee requested information on the existing pay equity claims that may potentially be impacted by the transitional provisions in Schedule 1 of the Bill.

## Response

- 3. The following table sets out the current pay equity claims in the State sector, that officials are currently aware of, however, the number of claims is dynamic. The transitional provisions in the Bill would apply to these claims.
- 4. There may be further existing claims in the private sector that would also be subject to the transitional provisions in the Bill however we are not aware of any.

Early Childhood Education Agreement of Aotearoa New Zealand (ECE collective agreement)	Note that these employees work for employers in the private sector that receive State funding. The number of FTEs is unknown.
Salvation Army collective agreement (this claim may include support staff)	NB. These collective agreements are not negotiated by the Secretary for Education.

In-training and unqualified teaching assistants, Administrators and Teacher Aides in kindergartens covered by the Kindergarten Associations Support Staff Collective Agreement. This includes 11 kindergarten associations and 392 kindergartens.	Employees are employed by the association or kindergarten which receive State funding. Claims raised by NZEI Te Riu Roa as part of the settlement of the Kindergarten Associations Support Staff Collective Agreement in November 2018.
